To lutruwita/Tasmanian Trail Runners

It is with great pride that I can write the first President's report for the Tasmanian Trail Running Association. From what started as an idea some 5-6 years ago, originating because of an overwhelming growth within our sport and a clear lack of guidance, governance, and structure to what is now our first incorporated peak body. Which is now being closely watched by fellow State entities and those who are looking at establishing a national body.

In our first official year of operation TTRA has held its first AGM, finalised the mission and pillars, written its constitution, finalised incorporation, had our first intake of membership, written a runner's code of conduct, written several stakeholder submissions and above all continued to converse with our community and our key stakeholders, just to mention a few of the first-year achievements. Stakeholder engagement has resulted in many new and promising interactions, not the least with the Parks and Wildlife Service. In many cases we have now become one of the first groups engaged for input and have also been mentioned within literature produced by PWS.

Now that we have been able to establish a lot of the formalities surrounding the formalisation of TTRA we are very excited to move on to our new projects in the coming year. Some of these new initiatives include an organisers guide and code of conduct, finalising the organisers event calendar, creation of a competitor's calendar, beginning structure and pathway development for all ages, continued input in stakeholder trail development and maintenance, and continued interactions with our governing bodies to establish pathway of governance that best represents our members and community.
